- A. Attendance at 50 % of the regularly constituted general meetings each year, one of which must be the meeting just prior to the KCP shows. The Annual Meeting does not count toward this requirement.
- B. Attendance at the KCP shows, and participation in the club's work of putting on the shows.

In addition to completing this form, applicants for membership must complete the following procedures:

- 1. File the Application for Membership.
- 2. Attend 3 regularly constituted meetings of the club. At these meetings, prospective members may participate in discussions, but not vote.
- 3. Working one KCP show in a variety of assigned tasks will count as attending a meeting. (Applicants must follow the same rules as apply to members. See above-C.)
- 4. When other procedures have been completed, acquire "the endorsement of two members of the club who have been in good standing for a period of not less than one year prior to such endorsement" (By-Laws: A D., S3, p2).

Membership is not automatic. Applicants must receive "affirmative votes of 3/4 of the members present and voting in secret ballot" (By-Laws: A IT., S3, p3)
